In order to be considered for Financial Aid on probation for the next payment period, you must submit a Satisfactory Academic Progress appeal. All appeals for fall 2022 financial aid eligibility **should be submitted by 5 pm on July 21, 2022.**

**APPEAL PROCESS:**

***Students must submit this form along with a typed appeal answering ALL of the following questions (failure to do so will result in a denied appeal):***

1. In detail, what were the documentable mitigating circumstances that caused you to fail to make satisfactory academic progress? **YOU MUST INCLUDE DOCUMENTATION OF THE MITIGATING CIRCUMSTANCES YOU DESCRIBE.**
2. In detail, what changes have (or will occur) to ensure you will make progress during the next academic year?
3. Your realistic academic plan for improvement.
  - Please utilize our academic planning system, UAchieve, and our GPA calculator on [www.ramapo.edu/myadvisor](http://www.ramapo.edu/myadvisor) to build a plan for future coursework.
  - You may also reach out to your faculty advisor or Student Success advisor for assistance; log onto Connect for the contact information of your assigned advisor.

All students granted aid on probation agree to a minimum academic plan to earn all attempted credits registered for at the end of the following semesters add/drop period with at least a 2.0 GPA for undergraduate students (3.0 for graduate students).

**Be sure to include your name and RID on all forms submitted.**

**ALL appeal letters must be typed** and postmarked, or uploaded to <https://mappingyourfuture.org/MappingXpress/RCNJ/> using the passcode Ramapo#1 to The Office of Financial Aid by the deadline of July 21st by 5pm. – Late appeals may be considered on a case by case basis with a written explanation as to why the initial deadline was missed. Students will be notified of the SAP Appeals Committee decisions within 2 weeks of submitting their appeal.
